**Description** CD24 is a 35-45 kD glycosylphosphatidylinositol (GPI)-linked protein also known as heat stable

antigen (HSA), BA-1, Ly-52, and nectadrin. It is expressed on the surface of B cells (but not plasma cells), granulocytes, follicular dendritic cells, and epithelial cells. CD24 may play a role in the regulation of B-cell proliferation and maturation. CD24 crosslinking induces a Ca2+ flux

in mature B cells. CD24 has been shown to interact with CD62P (P-selectin).

Formulation Phosphate-buffered solution, pH7.2, containing True-Stain Monocyte Blocker™, 0.09% sodium

azide, 0.2% (w/v) BSA (origin USA), and a stabilizer.

Preparation The antibody was purified by affinity chromatography and conjugated with APC/Fire™ 750 under

optimal conditions.

Concentration 400 µg/mL

Storage & Handling The antibody solution should be stored undiluted between 2°C and 8°C, and protected from

prolonged exposure to light. Do not freeze.


