Description CD5, also known as Leu-1, Ly-1 and T1, is a 67 kD single chain type I

glycoprotein that is a member of the scavenger receptor superfamily. CD5 is expressed on T cells, thymocytes, B cell subsets, chronic B lymphocytic leukemia (B-Cells), and peripheral blood dendritic cells. CD5 modulates T and B cell receptor signaling, thymocyte maturation, and T-B cell interactions. One of

its ligands is CD72.

Formulation Phosphate-buffered solution, pH7.2, containing True-Stain Monocyte Blocker™,

0.09% sodium azide, 0.2% (w/v) BSA (origin USA), and a stabilizer.

The antibody was purified by affinity chromatography, and conjugated with Preparation

PE/Cyanine7 under optimal conditions.

Concentration 25 µg/mL

Storage & Handling The antibody solution should be stored undiluted between 2°C and 8°C, and

protected from prolonged exposure to light. Do not freeze.

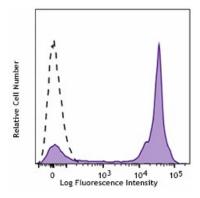
