Description CD25 is a 55 kD type I transmembrane glycoprotein also known as low affinity IL-

2 receptor α chain or Tac. It is expressed on progenitor lymphocytes, activated T and B cells, and activated monocytes/macrophages. CD25 is also expressed on a subset of non-stimulated CD4⁺T cells termed T regulatory cells. Soluble CD25/IL-2Ra is produced as a consequence of lymphocyte stimulation and is found in biological fluids following inflammatory responses. CD25 associates with IL-2 receptor β (CD122) and common γ (CD132) chains to form a high affinity IL-

2R complex.

Phosphate-buffered solution, pH7.2, containing 0.09% sodium azide, 0.2% (w/v) **Formulation**

BSA (origin USA), and a stabilizer.

Preparation The antibody was purified by affinity chromatography and conjugated with APC

under optimal conditions.

The antibody solution should be stored undiluted between 2°C and 8°C, and Storage & Handling

protected from prolonged exposure to light. Do not freeze.


